Conewango Township Board of Supervisors 4 Fireman Street Warren, Pennsylvania 16365 Meeting Minutes for April 9th, 2024

- 1. Meeting was called to order at 5:00 pm and the Pledge of Allegiance was recited.
 - Attendance: Supervisors: Zariczny, Gee and Duckett; Solicitor: Andrea Stapleford;
 Police Chief, Jason Peters; Officer, Charlie Anderson; Road Crew Foreman, Joe
 Papalia.
 - b. Public Comment:
 - Scott Harrington wanted to see where we were at with a Noise Ordinance. T. J. Allshouse spoke about changes made to address the noise issue with one of his well pumps. T. J. will continue to look into other solutions. Mentioned shrubs, fencing or other options that may help.

Greg Lindquist – sound is greatly improved. He hopes to build support and awareness of Noise Ordinance.

John Hamm – also in the area of the Allshouse well pump noise. Wanted to be informed – hopes for other solutions then waiting for the leaves on the trees.

Ray Reiff – 72 River Road behind Carter Lumber. Has been trying to alleviate the flooding issue on his property. Wanted to see if he could bore under the road to alleviate the flooding. Asked if he could have our permission to bore. Ray states he has a cistern and now pumps water that ends up in neighbor's yards. Jeff Z. informed him that we would look into the 2nd Class Township Code to see if he is able to bore under the road or what other options there may be. On a different topic Ray states that there used to be No River Access signs that are now missing in that area. Wondered if signs could be replaced and offered to pay for one of them. Jason Peters suggested we see what the original sign said on it and Joe will then obtain sign and put it up.

Ron Peterson – Wetmore Cemetery. Great progress being made. Much of the overgrowth is cut back. Jeff asked Joe P. to buy the cleaning supplies that Ron had requested. Ron also asked to have some clean fill dirt as the stumps have been removed and some areas are low. Asked for \$250 to pay Matt Wallin for stump removal. Jeff explained that we need an invoice from Matt and a check will be sent.

Daniella Langienese from the Times Observer introduced herself and explained that the newspaper wanted to do a better job of reporting about public happenings and that is why she was there.

- d. PennDOT Route 6 Construction Ongoing road work and lane closures from last year.
- e. EMC Coordinator LeeAnn Adams in her capacity as Pleasant Township secretary/treasurer suggested that Pleasant would like to share an EMC

Coordinator with us. Jim Zavinsky has been sent a letter to determine his interest. Compensation discussions will happen if he accepts.
